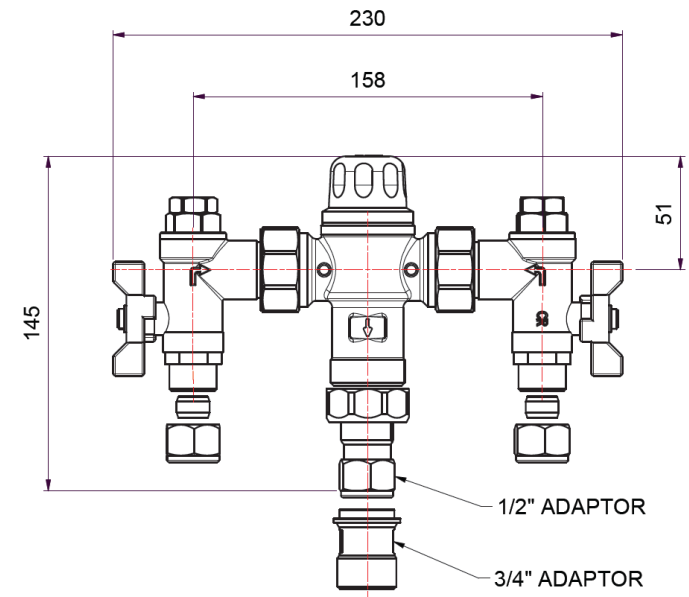

Features

- In the event of either hot or cold water supply failure the valve will shut down, quickly restoring flow when normal conditions resume.
- Water temperature is established at plus or minus 2 degrees even during water pressure or temperature fluctuations.
- Suitable for installation in low-pressure systems and will operate with working pressure as low as 20kPA.
- Can be installed in any configuration with the water outlet in the horizontal or vertical position, and inlet connections can be rotated to suit inlet pipework.
- Manufactured using Lead Free DZR Brass with less than 0.25% lead content

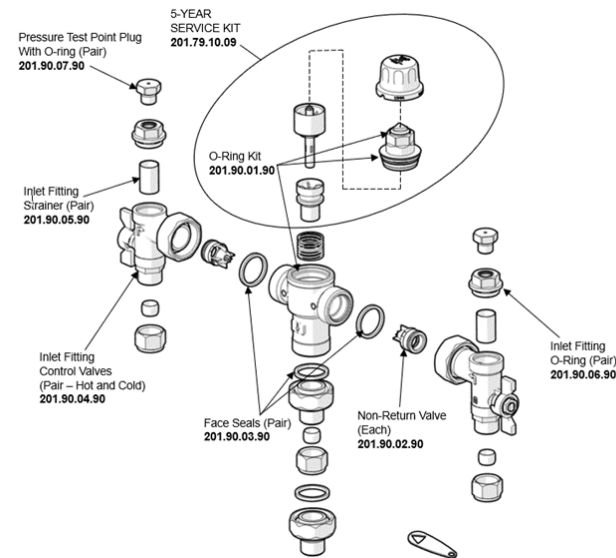
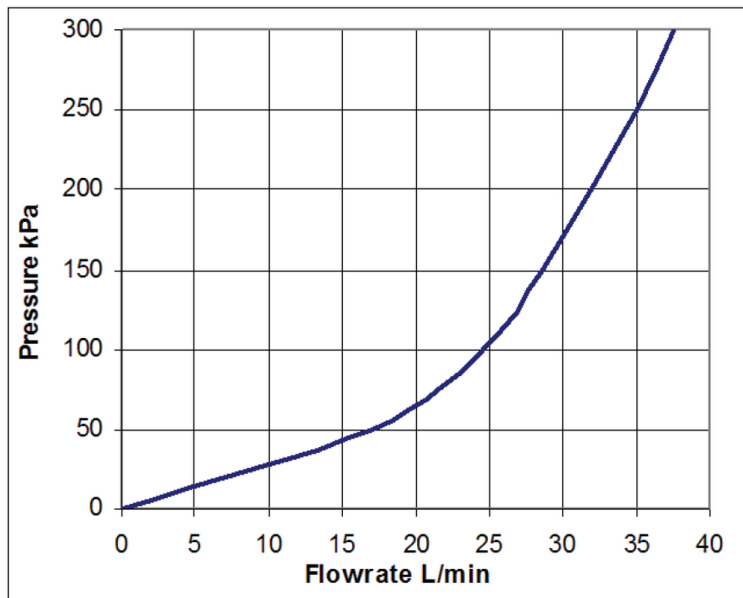

2) For optimal performance it is recommended that the hot and cold water supply pressures be balanced to within +10%. Excessive variation in supply pressures may cause changes in outlet temperature.
